Unit #1 was parked facing S to N in the parking lot of K-Mart in the parking aisle in front of the garden center entrance/exit. Unit #1 was struck in the left front by Unit #2 which was traveling S to NE in the parking lot. Officers went to 2440 Sycamore St to speak with Veronica Miller after she called in reporting that her vehicle was struck in the Wal-Mart lot. Veronica did state that she was at K-Mart before going to Wal-Mart. The damage and transfer paint to the Miller vehicle was consistent with the damage to the Stillion vehicle. Security video was obtained from K-Mart and placed into the case file.
