Unit #2 stated that he was exiting the parking lot of Riesbecks onto S. 23rd St from E to W. Unit #2 stated that he had stopped for traffic and that he was struck in the rear drivers side by Unit #1 which was traveling behind him. The driver of Unit #2 stated that he exited his vehicle to speak with the driver of Unit #1 and that they both looked at their vehicles and spoke. Unit #2 told the driver of Unit #1 he was going to take a picture and Unit #2 stated that the driver of Unit #1 got back in his vehicle and pulled away and left not leaving any information.

Unit #1 stated that he was exiting the parking lot of Riesbecks E to W and was in the left exit lane and that Unit #2 came over towards him from the right exit lane and slammed on his brakes causing him to slam on his brakes causing the two vehicles to collide.
