Re: Cambridge Municipal Court 2023 Annual Report

Pursuant to the provisions of Ohio Revised Code Section 1901.14, the Annual Report for the Cambridge Municipal Court for the year 2023 is submitted for your review and consideration.

2023 marked the end of an era for the Cambridge Municipal Court when Judge John Mark Nicholson officially retired as Judge of this Court on December 31, 2023, after serving this community for more than thirty years. Judge Nicholson leaves behind a staff of highly competent employees and many finely tuned procedures. He also is responsible for a plethora of entertaining stories that will surely continue to be told for many years to come. Judge Nicholson leaves behind giant shoes to fill. It is my great honor to have the opportunity to fill those shoes and to replace a legend. I am committed to providing prompt, fair, and impartial administration of justice to all that appear before the Court.

The data contained in this annual report is not my own and therefore I give all the credit for producing this report to the wonderful staff I have been very fortunate to inherit. Their dedication, skill and excellence are a testament to the truly exemplary leadership this community enjoyed with Judge Nicholson. Because this report does not detail work for which I can take any credit, I will instead use this introduction as an opportunity to highlight what we have done during my first 90 days in office, as well as to outline continued plans to make the Cambridge Municipal Court even better in the years to come.

First, I was extremely fortunate to convince Katie Howell to return to the Court and to accept the position of Court Administrator. Katie previously worked for the Court for more than 15 years before leaving to pursue other opportunities, Katie understands all the operations of the Court and its various departments and has

been an invaluable asset to me and the rest of the staff during these last three months.

I was also fortunate to retain all prior staff with the exception of Teresa Liston, Magistrate and Court Administrator and Mickie Capers, Assignment Commissioner who chose to retire

at the end of 2023. All other staff members navigated through a year of uncertainty in 2023 and chose to remain with the Court. All have worked diligently to ensure a seamless transition. The Court employees have embraced the inevitable changes that come with a new administration and have worked hard to develop and implement continued suggestions for improvement. The City of Cambridge and Guernsey County are fortunate to have such a talented group of dedicated people and I am blessed to have the opportunity to work with them daily.

It is one of my continuing goals to be fiscally conservative and responsible with the tax dollars spent by the Court. Therefore, I have chosen not to replace the prior magistrate which results in substantial savings. Given the current caseload, I can hear all cases that come before the Court. If the caseload increases, it may become necessary to consider the addition of a part-time magistrate to ensure prompt disposition of all cases.

In the last 90 days, I have reviewed the budget many times and have taken simple steps to eliminate spending wherever possible – from cancelling unused email accounts, outlook users and cell phones, to terminating book subscriptions where the same materials are available online. To date, through the small changes made, we have eliminated approximately \$5,000.00 in spending. I have personally reviewed and approved each and every expenditure made by the Court since January. I will continue to do so and will continue to eliminate any unnecessary spending identified so that taxpayer dollars that fund this Court are not wasted.

The Court is currently working to comply with all requirements of the Ohio Supreme Court which, when completed, will include a complete overhaul of the Court's Local Rules. The Court is currently working on various plans and procedures that are required and will complete those within the coming months.

Of particular note, the Court requested a security assessment from the Ohio Supreme Court which will be completed on March 26th. This assessment is one of the many services offered to local courts by the Ohio Supreme Court at no local cost. The purpose of this assessment is to review the current security procedures and systems to ensure that the Court is in compliance with all requirements of state law and, more importantly, to ensure that staff and visitors to the Court are safe each time they enter this building. More information regarding that assessment will soon be available.

Technology is simultaneously the best friend and greatest nemesis of the Court. The Court must be reliant upon technology to ensure that cases are managed properly, and that the public has ongoing access to Court information. Constantly developing and changing technology creates a challenge to the Court in trying to "keep up". The Court recently applied for a technology grant through the Supreme Court of Ohio to allow us to update, upgrade and improve the technology throughout the Court to meet those ongoing demands. Word on whether we will receive that grant will not come until later in spring.

The Court continues to work diligently to address the common problems facing our community: illegal drug use, mental health issues and the combination of the two. The court and its probation department continue to work tirelessly in attempts to hold offenders

accountable but also rehabilitate offenders to reduce or eliminate drug usage and deter recidivism. We have also continued to utilize electronic monitoring options, when appropriate, to reduce the jail population.

The Clerk's staff continues to pursue collection of fines and costs assessed by the Court and have continued to partner with Capital Recovery Systems, Inc. and the Ohio Attorney General's Office to pursue collection of past due amounts. In addition, the Court has recently implemented a Contribution In lieu of Community Service program pursuant to Ohio Revised Code Section 2929.27.

Pursuant to that code section, an offender who is ordered to perform community service as part of his/her sentence may elect to pay a reasonable sum in lieu of performing the service. Any funds received remain local and are paid to the general fund of the funding authority. This program is beneficial in two ways: first, it allows an individual who is financially unable to pay fines to instead perform community service, avoiding unnecessary collection costs and a continuing cycle of debt, while providing a service that benefits the Cambridge / Guernsey County community. In addition, in situations where individuals are employed and unable to work community service due to work schedules or other scheduling demands, they are provided with an option to make payment in lieu of performing service and that payment directly benefits the community. This program was initiated on January 31, 2024. In the limited time the program has been in effect, the Court has collected over \$4,000.00 in contributions in lieu of community service but has also continued to provide community service workers to perform valuable service within the community.

It is my privilege and honor to serve as the new judge of the Cambridge Municipal Court. I am pleased with the progress the Court has made during my first 90 days as Judge and I look forward to continuing those efforts in the months and years to come.

AUTHORITY & JURISDICTION

The Cambridge Municipal Court was established in 1952 as authorized by Ohio Revised Code Section 1901.01.

The Cambridge Municipal Court has territorial jurisdiction within Guernsey County, Ohio, including, but not limited to:

City of Cambridge Village of Pleasant City Village of Senecaville Seneca Lake Village of Byesville Village of Quaker City Salt Fork State Park

The Ohio Legislature establishes the territorial jurisdiction, as well as the subject matter of the Court. Additionally, the court is governed by the administrative rules of various state agencies, as well as the Supreme Court of Ohio. Generally, municipal courts in Ohio have the following jurisdictions:

- ♦ Felony cases (initial appearance/preliminary hearing)
- ♦ Misdemeanor cases (through final determination)
- ♦ Civil actions up to \$15,000.00, including evictions
- ♦ All misdemeanor traffic violations
- ♦ Selected administrative appeals

Cambridge Municipal Court Clerk of Courts

The Cambridge Municipal Court receives filings from all law enforcement agencies in Guernsey County as well as Civil and Small Claims filings within our jurisdiction. The Clerk's Office filed and entered into the database 5,708 new cases in 2023. The Court held a total of 1,745 arraignments and 128 preliminary hearings. Domestic Violence and Violation of Temporary Protection Order cases filed for 2023 was 101. There was a total of 113 OVI and Physical Control cases filed for 2023. A total of 7,680 cases were disposed of in 2023.

Court overall receipts for 2023 exceeded \$2,100,000.00, due to the diligence of the clerk's staff in their pursuance of fine collections and increased filings through the Civil Department.

The Court continues in partnership with the Ohio Attorney General's Office and Capital Recovery Systems, Inc. to aid in the collection of aged delinquent fines and costs, resulting in additional collections of \$29,215.00 in 2023 at no cost to the Court. Collection fees are paid entirely by the defendants. This free service allows the Clerk's Office to seize a delinquent debtor's State income tax refund to offset their unpaid fines and costs, which helps defendants to reinstate their forfeited license.

In 2023, the Small Claims Division continued with the City Prosecutor and the City Treasurer's Office as well as the City Utilities Department in pursuing and collecting past due income taxes and utilities respectfully. These efforts have been successful as the Court has collected and distributed \$11,660.00 to the City of Cambridge. As well, the Civil Division distributed over \$400,000.00 in Garnishments in 2023.

The Court continues moving forward with ongoing technology upgrades and enhancements to better serve the public, law enforcement, attorneys, and our community. There are a total of four agencies in our jurisdiction that are filing traffic violations via E-Citations with success. The Court continues to have success with the E-Search Warrants. The Court continues to utilize alternatives to in-person visits with the virtual hearings via the Court website. The Cambridge Municipal Court has undertaken the task of being the first Municipal Court to go forward with getting E-Warrants up and running. It is an ongoing process with all agencies. The Court is also setting up E-Filing, starting with the Civil Department.

I would like to state my gratitude and appreciation for the Deputy Clerks in the Clerk's Office for their willingness and acceptance of all the new job duties asked of them. They all are to be commended for their understanding, patience and cooperation.



Designated Funds

Understanding Their Purpose & Applications

SPECIAL PROJECTS FUND

The purpose of this fund is to acquire and pay for special projects of the Court including, but not limited to, the acquisition of additional facilities or the rehabilitation of existing facilities, the development and implementation of innovative programs aimed to improve access to justice and enhancing court efficiency, technology upgrades, training and education for court staff, specialized court programs, and other related services. The Court, by local rule, charges a Special Project fee on the filing of each criminal case, civil action or proceeding.

INDIGENT DRIVERS ALCOHOL TREATMENT FUND (I.D.A.T.)

Pursuant to state law, when individuals are charged with or convicted of operating a vehicle under the influence of alcohol or drugs, or refusing a breath test, their driver's license is suspended for a period of time. Once the suspension is over, the offender must pay a reinstatement fee to the BMV in order to become valid to drive. A portion of the reinstatement fee is directed to the I.D.A.T. Fund, administered by the Ohio Department of Alcohol and Addiction Services.

By law, the Municipal Court is required to have an I.D.A.T. Fund. These funds provide financial assistance to those who have been ordered into treatment programs such as rehabilitation, counseling and support services.

CLERK COMPUTER FUND

The Clerk Computer Fund is designed to specifically finance technological needs in the clerk of court's office. Funds are allocated to acquire, maintain and upgrade case management systems used for maintaining case records and managing the court's docket. This fund may also be used for the purchase of supplies, equipment, software applications tailored to electronic filing and/or to supplement salaries as needed.

INDIGENT DRIVERS ALCOHOL MONITORING FUND

Effective in September of 2008, Ohio law increased mandatory OVI fines and license reinstatement fees, each by \$50.00. Those fines and fees are deposited into this fund which the Court is required to establish. These funds are designed to be used exclusively for the cost of immobilizing or disabling devices, including ignition interlock and electronic monitoring devices as ordered by the Judge. A surplus in this fund may be declared and funds may be transferred to the I.D.A.T. fund.

COURT COMPUTER FUND

The Court Computer Fund has been established to address the broader technological needs of the entire Court system. It encompasses technological requirements including Judge's chambers, courtrooms, administrative offices and other departments within the court structure. This fund may be used to purchase supplies, equipment, software applications tailored to electronic filing and other broader technological needs across all departments.

PROBATION SERVICES FUND

A monthly probation supervision fee is assessed to all defendants admitted to a term of probation. These fees are deposited in the Probation Services Fund. This fund is used to provide necessary equipment and pay expenses for the Probation Department, including salaries. This fund also supports the Community Service Program.

EMHA GRANT FUND

In 2016, the Cambridge Municipal Court was awarded a grant from the Ohio Department of Rehabilitation and Correction, Division of Parole and Community Services, Bureau of Community Sanctions. The purpose of this grant is to help alleviate overcrowding in the Guernsey County Justice Center. Funds from this grant are used to pay for the cost of electronically monitored house arrest, continuing education for probation officers and/or supplement salaries as needed.

STATE OPIOD RESPONSE (S.O.R.) GRANT FUND (ENDED 2023)

The Ohio State Opioid Response Grant is a funding initiative aimed at addressing the opioid epidemic in the State of Ohio. It provided financial support to the Cambridge Municipal Court Probation and Pretrial Services Department to pay the salary of a probation officer. It also included funding for medication assisted treatment, peer support services and residential treatment programs. Unfortunately, the Court was notified in 2022 that the parameters of the grant had changed, and that funding would no longer be available for probation officer salaries. Therefore, the Cambridge Municipal Court is no longer eligible to receive this funding.


CONTRIBUTIONS IN LIEU OF COMMUNITY SERVICE FUND (CILOCS) (NEW 2024)

In 2011, Ohio Revised Code Section 2929.27(B) was enacted as part of Substitute House Bill 5 which deals with sentencing in criminal and traffic cases. It allows an offender who has been sentenced to a term of community service to request that the Court modify the sentence to authorize the offender to make a reasonable contribution in lieu of community service. These funds, by statute, are required to be deposited in the General Fund of the Court's funding authority, which are the City of Cambridge and Guernsey County, Ohio.

Cambridge Municipal Court Probation and Pretrial Services Department

Community Service

Over the last five years, our Community Service Program has grown considerably. We have extended community service working days to six days a week. Previously the program was only three to five days a week. Our program has helped the City of Cambridge with mowing, community clean up days and other projects and jobs. Our program also works with other agencies as well. When the Community Service Coordinator is unavailable, the Probation Department is responsible for the supervision of the workers. This often happens at the last minute. Our department has done a great job stepping up and taking on the extra responsibility. In 2023, Skip Wetherell was hired to be the Community Service Coordinator. Skip brings over twenty years of experience working with the City of Cambridge. Skip's experience has allowed for a great transition and has added great value to the Community Service Program.

Courtroom Security

In the past, the court has operated with two bailiffs. Currently the court has one full time bailiff. The Probation department is responsible for filling in as needed. The Probation Department assists with courtroom security as bailiff both in the courtroom and at the jail for video arraignments and trials. The Probation Department has taken on those responsibilities as well as continuing to engage in previous responsibilities. This has taken up more time and effort on each individual officer. The department has done a great job of taking on the new tasks.

Drug Testing

The Cambridge Municipal Court Probation and Pretrial Services Department conducts an average of seven to ten urine drug screens a day. We use instant urine cups to ensure immediate results. If there is a dispute from a defendant or they test positive for THC or any other drug that would take longer periods of time to clear from their system, we send those screens to a lab where they test the actual amount of that drug in their urine. The lab testing has provided the department with another tool to help us do our job in the most efficient manner. The department has also started conducting all of the new employee drug screens for any new hire from each department for the City of Cambridge.

Grants

CCA 2.0 Grant

This program allows the department to utilize GPS tracking and house arrest monitors in lieu of jail. The program significantly reduces the number of inmates in the Guernsey County Jail. The program typically has anywhere between 17-30 probationers/defendants on a monitor that would otherwise be incarcerated in jail. This program also provides the department with a way to monitor probationers more intensively which leads to less recidivism and higher compliance with conditions of bond and probation.

SEAT Grant

The SEAT Grant allows us to provide free transportation to probationers/defendants through Southeastern Ohio Transit. Probationer/defendants are required to report to the Probation Department for urine drug screens, appointments, counseling appointments, court appearances, etc. This grant reduces the number of warrants issued for people who are unable to find transportation, causing a Failure to Appear, and helps with compliance of bond and probation.

Pretrial Services

In 2023, the department hired Probation Officer Dominique Banister. Dominique brings eight years of experience working as a probation officer and as a corrections officer including five years as a probation officer at Guernsey County Common Pleas Court Adult Probation Department. Her experience has been a major asset to this department.

The Pretrial Services Department also supervises felony pretrial cases. During the transfer of felony cases, the Pretrial Services Department works with Guernsey County Common Pleas Court Adult Probation to ensure there is no gap in supervision. Officer Dee McInerney is the assigned Felony Bond Officer on these cases, and she has gone above and beyond to ensure compliance with defendants.

Probation and Pretrial Supervision

Currently, the Cambridge Municipal Court Probation and Pretrial Services Department supervises approximately 550 total probationers/defendants. This number does not include active warrants. To put this in perspective, Guernsey Court Common Pleas Court Adult Probation currently supervises 245 people.

Probation Fees

It is the responsibility of officers to ensure the collection of probation fees from probationers. It is now standard practice for officers to routinely go over this topic with probationers to ensure compliance with paying fees. In 2021 the department collected \$169,759.40. In 2022, the department collected \$120,315.99. In 2023, the department collected a total of \$188,210.91


